Section 6 LOW DENSITY RESIDENTIAL (R1) ZONE

6.1 Low Density Residential Zone Regulations

No person shall use any land or erect, alter or use any building or structure in the Low Density Residential - R1 zone except in accordance with the following provisions.

6.2 Permitted Main Uses

- 1. Duplex Dwelling
- 2. Single Detached Dwelling
- 3. Semi-detached dwelling
- 4. Group Home subject to Section 4.12
- 5. Group or Group Housing or Group Housing Project
- 6. Public Authority Use or Public Utility subject to Section 4.31

6.3 Permitted Accessory Uses, Buildings and Structures

- 1. Accessory Uses, Buildings and Structures subject to Section 4.1
- 2. Accessory Apartment or Apartment-in-a-House
- 3. Bed and Breakfast Establishment subject to Section 4.2
- 4. Garden Suite subject to Section 4.11
- 5. Home Based Business subject to Section 4.13

6.4 Zone Requirements

The zone requirements for permitted uses in the R1 Zone shall be as set out in Table 6.4.

6.5 Additional Provisions

- 1. The minimum *interior side yard* shall not apply to the party wall shared between two *semi-detached dwelling units*.
- 2. A garden suite shall be subject to a Temporary Use By-law under Section 39 of the Planning Act and shall only be permitted as an accessory use to a single detached dwelling.
- 3. All applicable provisions of Section 4 General Provisions shall apply.
- **4.** A existing lot of record in an approved subdivision created prior to April 17, 2002 may be developed for a single detached dwelling provided the minimum *lot area* is 350 m² [3,767.4 ft.²] and the minimum *lot frontage* is 10 m [32.8 ft.]. (By-law 992)
- 5. The requirements of **Table 6.4** shall apply only to a *semi-detached Group or Group Housing or Group Housing Project* as follows:
 - a. The minimum lot area shall be 500 m² [5,382.1 ft.²] per dwelling unit.
 - **b.** The minimum *lot frontage* shall be 30 m [98.4 ft.].
 - c. The maximum number of dwellings shall be 6.
 - **d.** The minimum separation distance between *dwellings* shall be 6 m [19.6 ft.].
- 6. A private garage may be erected on a lot in the Low Density Residential (R1) Zone where the lot is not occupied by a dwelling provided the private garage is not used or occupied as a dwelling, and provided that the location of the private garage will not prevent the construction of a dwelling on the same lot which will meet the required setbacks of the R1 zone.
- 7. A storage container shall not be permitted as an accessory use in the Low Density Residential (R1) Zone.
